

# **ORDINANCE NO. 451**

## **Emergency Operation Plan**

### **AN ORDINANCE OF THE CITY OF MACKAY, CUSTER COUNTY, STATE OF IDAHO, FINDING FACTS; ESTABLISHING A CITY EMERGENCY OPERATIONS PLAN; PROVISIONS DEAMED SEVERABLE; DISPENSING RULE TO PUBLISH; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, no Emergency Operations Plan was found to exist for the City of Mackay; and,

WHEREAS, the Mayor is responsible for declaring of emergencies and the safety of Mackay citizens during a declared emergency; and,

WHEREAS, emergencies have been identified which may occur in the City which could endanger lives and property; and,

WHEREAS, it would be in the best interest of the City of Mackay to develop and implement an Emergency Operations Plan;

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MACKAY, CUSTER COUNTY, IDAHO:

SECTION 1: Any and all Ordinances, Resolutions, and minutes of City Council meetings which contain references to emergency actions or emergencies are hereby repealed ; and

SECTION 2: The Mayor and City Council have determined it to be in the best interest of the City; to adopt and implement an Emergency Operations Plan for the City of Mackay; and,

SECTION 3: The Mayor and City Council hereby adopts the City of Mackay Emergency Operations Plan dated March 2019 and any future updates to that Plan; and,

SECTION 4: The City of Mackay Emergency Operations Plan may be updated and/or amended without having to amend this Ordinance.

SECTION 5: If any section, paragraph, sentence or provision hereof or the application thereof to any particular circumstances shall ever be held invalid or unenforceable, such holding shall not affect the remainder hereof, which shall continue in full force and effect and applicable to all circumstances to which it may validly apply.

SECTION 6. This Ordinance shall be in full force and effective upon its passage and publication according to law, the Council dispensing with the rule that ordinances must be read on three (3) different days, all as provided by law.
