

## ORDINANCE NO. 429

AN ORDINANCE OF THE CITY OF MACKAY, CUSTER COUNTY, STATE OF IDAHO, REPEALING ORDINANCES NUMBER 279, 288, AND 289 AND ANY RELATED RESOLUTIONS TO THOSE ORDINANCES OR DECISIONS MADE AND RECORDED IN THE MINUTES OF CITY COUNCIL MEETINGS; REVISING THE CITY OF MACKAY REQUIREMENTS FOR DRIVING AND PARKING OF VEHICLES; PROVIDING THAT VIOLATION OF THIS ORDINANCE SHALL BE PUNISHABLE AS AN INFRACTION IN ACCORDANCE WITH LAWS OF THE STATE OF IDAHO; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MACKAY, CUSTER COUNTY, IDAHO:

SECTION 1: Ordinances of the City of Mackay No. 279, 288, and 289 are repealed in their entirety. Also repealed are any Resolutions or decisions recorded in the minutes of the City Council related to these Ordinances.

SECTION 2: It is hereby declared to be the intent of the City Council to aid and assist by whatever means possible, for the consistency in traffic regulation among and between agencies of Idaho having such jurisdiction. Toward that end, adoption of the Idaho Motor Vehicle Laws by the City of Mackay is a necessary means of assuring maximum uniformity within the State.

The City hereby adopts for the purpose of establishing rules and regulations for the use of all streets and public thoroughfares of the City the Idaho Motor Vehicle Laws, more particularly Title 49, Idaho Code, and as the same may hereafter be revised by the Idaho Legislature, or amended by the governing body, and the same is hereby adopted and incorporated as an ordinance of the City as fully as though set forth at length herein.

The current Idaho Motor Vehicle Laws, shall be made available electronically by the City Clerk, for use and examination of and by the public or may be obtained at <http://legislature.idaho.gov/idstat/Title49/T49.htm>.

SECTION 3: In accordance with Idaho Code, Title 49 Chapter 2, Section 207, the City of Mackay may establish, by Ordinance, the speed limit(s) to be posted on the streets of the City.

SECTION 4: On-Street Parking on the City Right-Of-Way shall be parallel with the street and five (5) feet from the maintained edge of the street; unless, there is sufficient space to angle park such that the vehicle so parked is a minimum of five (5) feet from the maintained edge of the street. Parking on Main Street between Salmon and Spruce Streets shall be angle parking as indicated by pavement markings. Parking in alleys is prohibited.


SECTION 5: The City of Mackay may also establish, by Ordinance, the use of Mackay City streets and alleys by other types of vehicles, or modes of transportation which may currently be prohibited by Idaho Code.


SECTION 6: Any person found violating this Ordinance shall be guilty of an infraction and subjected to fines and penalties upon conviction as established by the State of Idaho.

SECTION 7: This Ordinance shall be in full force and effect immediately upon its passage and publication according to law, the Council dispensing with the rule that ordinances must be read on three different days, all as provided by law.
