

**ORDINANCE NO. 435**

**AN ORDINANCE OF THE CITY OF MACKAY, CUSTER COUNTY, STATE OF IDAHO, REPEALING ORDINANCE 233 WHICH IS NO LONGER PERTINENT TO THE ACTIVITIES IDENTIFIED IN SAID ORDINANCE AND THE CITY OF MACKAY; ADOPTS TITLE 39 CHAPTER 26 KNOWN AS THE "FIREWORKS ACT OF 1997;" AND PROVIDING AN EFFECTIVE DATE**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MACKAY, CUSTER COUNTY, IDAHO:

SECTION 1: This Ordinance repeals Ordinances 233 as identified below as it no longer reflects how the City of Mackay regulates fireworks:

**Ordinance #233** An Ordinance Of The City Of Mackay, Custer County, Idaho, Repealing Ordinance No 127 And Enacting An Ordinance To Be Known As The Mackay Fireworks Ordinance; Prohibiting And Enumerating Dangerous Fireworks; Permitting And Enumerating Safe Fireworks, Providing Exemptions From This Ordinance; Providing A Penalty For Violation, An, Establishing The Time This Fireworks Ordinance Will Go Into Effect


SECTION 2: The City hereby adopts Title 39, Chapter 26 known as the "Fireworks Act of 1997," for the purpose of establishing rules and regulations for use of fireworks within the Limits of the City of Mackay, and as the same may be revised hereafter by the Idaho Legislature, or amended by the governing body, the same is hereby adopted and incorporated as an ordinance of the City of Mackay fully as though set forth at length herein.



SECTION 3: This Ordinance shall be in full force and effect immediately upon its passage and publication according to law, the Council dispensing with the rule that ordinances must be read on three different days, all as provided by law.
