Sewer and Water Service Agreement in accordance with City of Mackay Ordinance 423

request/have requested that sewer and water service be established. If I am approved and the services are made available to me by the City of Mackay, I agree to abide by the conditions established in City of Mackay Ordinance #423 #423-7(e). I will be provided upon request a copy of City of Mackay Ordinance 423 (or subsequent ordinance(s) passed amending or changing said Ordinance). #423-15(b) The following excerpted conditions are included here for ease of reference to Ordinance #423 only and are not all inclusive:

1. pay a connection and turn on fee (new service only); #423-7(b)
2. pay a deposit fee (new service only); #423-7(d)
3. pay a yearly guarantee fee; #423-7(c)
4. pay additional monthly water usage fee when water exceeding the base amount is used (as determined by meter); #423-20(b)
5. pay an additional 10% late fee if the required fees are not received by the City of Mackay by the 15th of the month in which the fee is due; #423-20(h)
6. pay an interest rate of 5% on the unpaid balance due (including any late fee) until the account is paid in full; #423-20(i)
7. accept placement of a lien on my property by the City for failure to pay all unpaid balances; #423-22
8. limitations on the amount of water usage (Contract users only)

The above fees are established by City Ordinance and associated Resolutions and are subject to change on an annual basis. #423-17

I agree not to share, re-sell, nor sub-meter water to any other location unless approved by the Council of the City of Mackay. #423-33

I agree not to make any physical connection between a private water system and the City of Mackay's water system. Representatives of the City of Mackay may at reasonable times come on to the premises where the sewer and water service is being provided for the purpose of reading meter or conducting an inspection to insure compliance with this or any other provision of this agreement. Violation or non-compliance with this agreement and Ordinance 423 will result in discontinuation of service and possible Ordinance violation penalty fees, #423-9, -11(a) & (b), -12(a), and -36

I agree that the piping from the distribution main to and including the meter is and shall remain the property of the City of Mackay. The City of Mackay may remove the meter without notice

upon discontinuation of service for any reason. I, as the owner am responsible for the piping from the meter. #423-5(a), -8(g),

I agree that the City of Mackay reserves the right to terminate sewer and water service upon change of ownership, business type, or any significant changes to the system that may have an adverse affect on the City of Mackay services. I acknowledge that service may also be discontinued for failure to comply with the terms and conditions of this agreement and City of Mackay Ordinance 423 (or subsequent Ordinances), or failure to pay monthly fees. #423-7(f) & (g), 12(a)

I acknowledge that the City of Mackay will continue to charge base rates and fees whether the service is being used or if the service has been discontinued for any reason. I will pay such fees. #423-7(c)

By signing this Agreement, I concur that I have read and understand the conditions regarding this Water User Agreement.
